Charity Care is available to New Jersey residents who are uninsured, underinsured, or ineligible for state and federal programs. You will be screened to determine if you are eligible for the State of NJ Medicaid program (NJ FamilyCare). To qualify you must meet both the income and assets eligibility criteria. Charity Care covers hospital care only.

Charity Care Application Instructions

NJ FamilyCare covers: children, pregnant women, parents/caretaker relatives, and single adults/childless couples. Children 18 and under are eligible with higher incomes up to 355% FPL (\$7,751/month for a family of four). Parents still need to renew the coverage each year. Parents/Caretaker Relatives with income up to 138% FPL (\$3,013/month for a family of four) must have tax dependent children in their household in order to be eligible under this category.

NJ FamilyCare - Income Eligibility and Cost

New Jersey Medicaid Definition. Medicaid is a wide-ranging, jointly funded state and federal health care program for individuals with limited income and resources, and is intended to assist individuals of all ages.

New Jersey Medicaid Eligibility: 2020 Income & Asset Limits

If your family income is below 300% of the Federal Poverty Guidelines, you may be eligible for one of the low income assistance programs (e.g., Medicaid or Charity Care). If your income is 300% or above, and you have no insurance, you will be eligible for a hospital discounted fee equal to the “amount generally billed” for emergency or other medically necessary services.

If the patient earns 250% or less than the federal poverty guidelines, that

patient is eligible for 100% financial assistance and for UPMC service fees to be waived.

What to Know About Hospital Financial Assistance Policies ...

Financial Eligibility—Income: You will be eligible for full Charity Care coverage in 2018 if your annual gross income for the 12 months before your hospital care was not more than 200% of the federal poverty level, which is \$24,280 in 2018 for a single person. If your annual gross income is more than 200% of poverty but does not exceed 300%, Charity Care will cover up to 80% of your total bill based on a sliding income scale.
