The Nuremberg trials that prosecuted Nazi physicians from 1945 to 1946 for their unethical human experimentation during World War II initiated public discussion of research ethics involving human subjects. Established in 1947, the Nuremberg code differentiated between therapeutic and non-therapeutic experimentation, and this distinction heightened public awareness of the therapeutic intent of medical research [12].
